They were examined by us under consideration of the

(BfR-“Collection of methods for the examination of paper and board for food contact” of the, current state), in connection with the BfR guideline “Examination of the transfer of substances from consumer products made of paper and board”, as of 26.02.2015),

for the used raw materials, fabrication additives and special paper finishing agents as well as for the release of substances which might endanger health.

Furthermore, the board grades were examined for the migration of certain elements according to the

DIN EN 71, part 3 "Safety of Toys, Migration of Certain Elements", state of June 2021,
and the absence of non-approved amines and dyestuffs according to the

DIN EN 71, part 10 "Safety of Toys, Organic chemical compounds – Sample preparation and extraction", state of March 2006,
as well as the

DIN EN 71, part 11 "Safety of Toys, Organic chemical compounds – Methods of analysis", state of January 2006.

The board grades are in compliance with the rules of the

Moreover, they fulfill the demands of the

Directive 2009/48/EC of the European Parliament and of the Council of 18 June 2009 on the safety of toys, Official Journal of the European Community L 170/1 of 30 June 2009, last amendment by Commission Directive (EU) 2020/2089 of 11 December 2020, Official Journal of the European Union L 423/58 of 11 December 2020, Article 10,

regarding their chemical properties for scraped toy materials.

The demands of the

DIN EN 71, part 3 "Safety of Toys, Migration of Certain Elements", state of June 2021,
concerning the migration of certain elements are kept.

Furthermore, the demands on organic-chemical compounds applicable for paper according to
the

DIN EN 71, part 9 "Safety of Toys, Organic chemical compounds – Requirements", state of
September 2007,

are met by the grades.

Thus the multi-layered board grades **KROMA® Natural White** and **KROMA® Kraft**, according
to the sample material submitted, can be used as intended. They may be used as intermediate
layer or coasters in direct contact with dry, non-fatty foodstuffs as well as for secondary pack-
aging.
